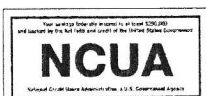
We are happy to service your request for a Home Equity Loan. Please adhere to the following:

If you receive a pension or social security, we will need a copy of the most recent statement for each.
3. Submit a copy of the most recent mortgage statement.
4. If you are using these funds to consolidate debt, please provide a recent statement from each creditor that includes your full account number, balance to be paid, and an address where we will send the funds.
5. Sign the insurance form stating you agree to provide proof (policy) of homeowners and/or flood insurance. And agree to list Reliance FCU as the lien holder.

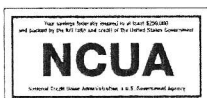
